**PLEASE TAKE NOTICE** that any qualified elector of the Township of New Buffalo who is not already registered, may register to vote at the office of the New Buffalo Township Clerk; the office of the County Clerk; a Secretary of State branch office, or other designated state agency. Registration forms may be obtained at the office of the New Buffalo Township Clerk or at [mi.gov/vote](https://mi.gov/vote) and mailed to the New Buffalo Township Clerk. Voters who are already registered may update their registration with the New Buffalo Township Clerk or at [www.expressSOS.com](https://www.expressSOS.com).

The last day to register in any manner other than in person with the local clerk is **Monday, October 21, 2024.**

After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.497) at the New Buffalo Township Clerk's office, located at 17425 Red Arrow Highway, New Buffalo, MI 49117 at the following times:

- Regular Business hours:  
Monday – Friday from 9 a.m. 12:30 p.m. and 1:30 p.m. to 4:00 p.m.
- Saturday, November 2<sup>nd</sup> from 9:00 a.m. to 5:00 p.m.
- Election Day: Tuesday, November 5<sup>th</sup> from 7:00 a.m. to 8:00 p.m.
