#### General

Mechanical work shall not be started until the application for the permit has been filed with the Township Building Department. All installations shall be in conformance with the State Mechanical Code. No work shall be concealed until it has been inspected. The telephone number for the Township Building Department will be provided on the permit form. When ready for inspection, call the Township Building Department providing as much advance notice as possible. The Township Building Department will need the job location and permit number

#### **Expiration of Permit**

A permit remains valid as long a work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within 180 days after issuance of the permit or if the authorized work is suspended or abandoned for a period of 180 days after the time of commencing the work. A permit will be closed when no inspections are requested or conducted within 180 days of the date of issuance or the date of a previous inspection. Closed permits cannot be refunded. The charge to re-open a closed permit is \$75.00
