**n. Special Land Use Approval – Fatouros Media Inc.**

Males moved, Heit supported, granting final approval of a Special Land Use to Fatouros Media Inc to operate a Banquet Hall and Event Center at 16130 Red Arrow Hwy, Union Pier, Michigan 49129; being parcel number 11-13-0336-0002-02-2.

**CONDITIONS OF APPROVAL:**

1. Evidence of agreement to provide a minimum of 25 parking spaces within 500ft of the property. Copy of such agreement must be kept current with the Building & Zoning Department Administrator. Failure to provide such would be considered a violation of the approved SLU;
2. Applicant has provided an updated site plan that includes 6 parking spaces onsite with one handicapped accessible. Outdoor lighting must be done in accordance with New Buffalo Township Ordinances;
3. Applicant shall maintain current business license registration with the New Buffalo Township Building Department, which includes an annual Fire Code Inspection of the premises;
4. This SLU development agreement be promptly recorded with the Berrien County Register of Deeds and a copy of such recorded documents must be provided to the Township within 45 days;
5. The SLU is attached to and shall run with the land for which the permit is granted, and shall be binding upon, and inure to the benefit of, all subsequent owners and all occupants of the subject land.

Discussion was held.

Males moved, Heit supported, granting final approval of a Special Land Use to Fatouros Media Inc to operate a Banquet Hall and Event Center at 16130 Red Arrow Hwy, Union Pier, Michigan 49129; being parcel number 11-13-0336-0002-02-2.

**CONDITIONS OF APPROVAL:**

1. Evidence of agreement to provide a minimum of 25 parking spaces within 500ft of the property. Copy of such agreement must be kept current with the Building & Zoning Department Administrator. Failure to provide such would be considered a violation of the approved SLU;
2. Installation of 6 parking spaces onsite is complete, including one handicapped accessible parking space. Outdoor lighting must be done in accordance with New Buffalo Township Ordinances;
3. Applicant shall maintain current business license registration with the New Buffalo Township Building Department, which includes an annual Fire Code Inspection of the premises;

4. This SLU development agreement be promptly recorded with the Berrien County Register of Deeds and a copy of such recorded documents must be provided to the Township within 45 days;
5. The SLU is attached to and shall run with the land for which the permit is granted, and shall be binding upon, and inure to the benefit of, all subsequent owners and all occupants of the subject land.
